1. STATUS

5. NUMBER OF STARTERS

7. DOCUMENTATION, AUDITING & DRIVERS BRIEFING

Documentation and auditing will be held at Awastone, Mangaweka on Saturday morning the 11th March 2023 at 10.00 a.m.

Drivers must complete the indemnity form (attached). All drivers must attend the driver's briefing held at the start of the day (see the itinerary for times). Documentation will go more quickly if entrants are able to print off and complete the attached entry form prior to the day,
